The abstract is written in English using the font Times New Roman of size 12.

Abstract in English should be provided even for papers written in Arabic.

Introduction (Times New Roman, 12, Bold)

The paper text is written with the font Times New Roman of size 12.

A table's title is written above the table with the font Times New Roman, 11, Bold

Data inside the table is written with the font Times New Roman, 10, Bold.

Titles of figures, drawings, and pictures are written below the figure with the font Times New Roman, 11. For Example:

Equations are prepared with Equation Editor, and numbered serially, as in this example:

$$y = \int_{\infty}^1 3x^3 + 3x - \frac{1}{3} \frac{dy}{dx} \quad (1)$$

The references are written in one of the following two methods:

1. Method 1: to mention the reference within the text, writing the author's name and publishing year, e.g. (Garnero and Godone, 4, 2013)...

Or, for an Arabic reference (أحمد جاب الله و محمد حدود، 2014)

In this case, references are arranged alphabetically, listing Arabic references first, then the references in English (or any other language). For example:

References (Times New Roman, 12, Bold)

2. Method 2: to place, in the text, a reference number next to the quoted statement, like this [1].

In this case, references are numbered and arranged according to their priority as mentioned in the text. For example
